2010 STREET DANCE VOLUNTEER INSTRUCTIONS - GATE

GENERAL INSTRUCTIONS

- Cash machine available inside of Ice Arena
- BLUE POLO SHIRTS identify 4th of July Committee members. If you have questions and can't find Deb Heinecke, Stacie Karkhoff or Brandon Klement, Ice Arena Manager, ask one of them
- The street dance is open from 6:00 to 11:00PM. The band plays 6-11PM. Ticket sales to purchase alcoholic beverages STOPS at 10:30 PM; serving of alcoholic beverages STOPS at 11:00. These times MUST be
- Eight police officers will be at the event; one at every gate, one at the beer stand and others roaming the crowd.
- All volunteers still at the event at 11:00 are asked to monitor the crowd as it leaves to make sure no alcohol is taken outside the gates. The police will "sweep" the crowd out at 11:00 PM. Also, we REALLY can use help in cleaning up. It can be done in a half-hour if everyone helps. If there are enough people at the gates, we can start cleaning at 11:00 or as the crowd vacates tables.
- Every volunteer will get 2 tickets for alcoholic beverages as a thank you. Pick them up at the info tent after your shift. Those working the last shift should get them before and consume the beverage BEFORE working. No alcohol can be consumed while working. Water and pop may be consumed.
- · Check in at the info booth

GATE SPECIFICS:

There are 3 entrances: 1) north end (ice arena), 2) east (from car sale area) and 3) south (66th St.). 5-6 people will work at each gate from 5:30 until 11:00 (North Gate will open at 6 PM & East Gate will close at 9:30 PM.)

We will have a scanner at each gate. One volunteer will scan ID's; this will help to pick up fake ID's. One person will take money. The other volunteers will put wristbands on. The entrance into the Street Dance will be under the pop up tents. The tents will have orange fencing to divide the tent. One side will be for adults with ID's to get wristbands. The other side of the tent will be for underage people to enter so they do not have to wait in line.

Main Duties

- 1) to check/scan ID's, ask police for help as needed
- collect \$5 (includes sales tax) from everyone over 21 without a 4th of July button
- put wrist bands on those over 21
- check coolers NO alcoholic beverages are to brought INTO the fenced-in area
- Prohibit alcoholic beverages from leaving the fenced areas.

Checking ID's: The purpose of the band is to tell ticket and drink people that their ID's have been checked. Also it tells gate people that they have already paid \$5 if they leave and want to come back in (ex. to see car show). For ID's, the magic date is 7/3/89. The wristbands MUST be on snug at the narrowest part of the wrist so that person can't slide it off and give it to someone under 21 (a problem previously), but not too tight that it's uncomfortable. NO Exceptions!

ALL coolers must be checked. NO alcoholic beverages must be brought into the fenced area. NONE must leave the fenced area. The liquor license is only for our sales consumed inside the fenced area. If you suspect someone is underage and drinking, or has had too much (even before entering), IMMEDIATELY find a police officer or a committee member (blue shirt).
